**Magistrates concerned for their safety:** It was reported that the Judicial Officers Association has called for better protection for magistrates. According to the report, in the last ten years at least seven attacks have been made on magistrates. The report also said that despite the security measures which had been implemented, including placing of 24 hours security in courts, some concerns still remained as magistrates "received regular death threats." In referring to the problem, a magistrate, Vincent Ratshibvumo, said that "every day we send people to prison (...) we deserve protection, not just for us, but for our families." **Detainee re-arrested after attempt to escape:** IOL reported that an awaiting trial detainee who had escaped at the High Court in Johannesburg had been re-arrested by police. According to the report, eight awaiting trial detainees attempted to escape from the court where they were supposed to be tried on Thursday 2 September 2010. The report also said six of the detainees had been re-arrested within the court building and on the street outside the court. **Suspects re-arrested after escape from court cells:** It was reported that the police re-arrested four suspects who had escaped from the Khayelitsha Magistrate Court cells in September 2010. The report said the men were being accused of killing a lesbian, Zoliswa Nkonyana, in February 2006. The report further said that the suspects were rearrested after four days of terror for the witnesses who feared for their lives. **Policemen arrested after court escape:** IOL reported that thirteen policemen were arrested in connection with the escape of eight awaiting trial prisoners from the High Court in Johannesburg in mid-September 2010. The report said that the arrest of the officers had followed investigations into possible misconduct, gross negligence and aiding prisoners to escape. **Auditor General more satisfied with DCS asset management:** It was reported that the Auditor General's report on the Department of Correctional Services stated that there were some improvements in the Department's asset management. The report said in his qualified opinion the Auditor General, Terence Mombembe, said that there were fewer errors than there were found in 2008-09 financial year. The report also said that despite the improvements recorded the Department is still failing to apply fair value to some assets which caused overvaluation of some of the Department's assets. **DCS ignores Jali recommendations:** A report said that five years after the report of the Jali Commission on corruption, maladministration and violence in the Department of Correctional Services (DCS) had been submitted to government, the key recommendations in the report had not been implemented. **Police criticised for delay:** The Witness reported that a judge from the Durban High Court handed down a judgment in which he criticised the police for having delayed to bring a suspect to court within 48 hours after arrest. The report said that the suspect was arrested on 27 August 2009, but only brought to court on 6 November 2009. The report further said that there was no exception to the 48 hours time limit in the matter. It also said that the judge, who had acquitted the suspect, was not satisfied with a statement that the suspect had confessed the crime freely. **Concerns over incidence of serious crimes:** Business Day reported that the annual report of the National Prosecuting Authority (NPA) claimed an 88% rate in successful prosecutions. However, the report said that the annual report of the NPA read together with the annual report of the police showed that the country faced problems with the incidence of serious crimes with 75% chances of offenders getting away unpunished. **Restricted leave to appeal a stumbling block to Selebi:** The Mail & Guardian reported that former police commissioner, Jackie Selebi, had been granted with a restricted leave to appeal after he was sentenced in connection with charges of corruption in August 2010. The report said that the restricted leave to appeal represented a setback for Selebi and his legal team as it only allowed them to appeal on one ground, which did not include, among others, the fact that he had not received a fair trial. **Sentence handed down 20 years later:** It was reported that a court sentenced a man to fifteen years of imprisonment for raping a fourteen year-old girl in 1990. According to the report, the delay in handing down the judgement is related to the fact that the offender had relocated himself before the prosecution had completed investigations. **NPA denies that the Child Justice Act is soft on child offenders:** The National Prosecuting Authority (NPA) denied claims that the new Child Justice Act had contributed to allow children to get away after committing offences. According to the report, a concern was raised that children were escaping the criminal justice system after the Standing Committee on Community Safety visited the Pollsmoor Prison and found that only nine children were incarcerated against 276 in 2009. **Speculations over probable release of Derby Lewis:** A report said that there are speculations that Clive Derby Lewis, the killer of Chris Hani, may be released on parole before 25 December 2010. However, the report also said that whilst there is such speculation the SACP spokesperson, Malesela Maleka, said that his institution "will oppose any plans, through any means available" to ensure that Lewis is not freed on parole. **Less than 50% of 2009 parolees are alive:** Beeld reported that less than half of the offenders granted medical parole in 2009 are still alive. According to the report, the number of parolees who are alive included Schabir Shaik and other parolees who were released in 2009. **System criticised after parolee commits another offence:** It was reported that the South African justice system had been criticised after an offender on parole was imprisoned for committing another violent crime. The report also said that legal experts and politicians who had criticised the system said that Leeuskieter was supposed to be in prison "at the time he attacked the helpless pensioner." **Overcrowding contributes to AIDS and TB in KZN prisons:** It was reported that overcrowding had contributed to the spread of HIV and tuberculosis in KwaZulu-Natal prisons and that many prisoners have lost their lives as a result. According to the report, there are cases where cells meant for 20 prisoners are holding 80 prisoners. The report said that this had contributed to the spread of the diseases. **Judge allows Derby-Lewis to get treatment:** Beeld reported that a judge from the North Gauteng High Court ordered that Clive Derby-Lewis should get daily treatment from a private doctor. The report said that Chris Hani's killer sustained an injury in prison. ### ANGOLA

**Brother of deceased journalist claims he had been tortured:** A report said that the brother of a journalist who had been accused of forging a signature on an official document claimed that his brother was tortured before he died in April 2010. According to the report, this information contradicted a statement by the Minister of Justice, Amadou Ali, who had earlier said that there were no signs of cuts or any other marks of torture which were found on the body of the deceased. **Tycoon gets fifteen years imprisonment on second trial:** A report said that a court in Egypt sentenced an Egyptian tycoon to fifteen years imprisonment for having ordered the murder of a Lebanese singer. The report said that Hisham Talaat Moustafa, a senior member of the Egyptian ruling party, had initially been sentenced to death, but judges set aside the initial decision on allegation of errors of technicalities and ordered a new trial, which culminated with a sentence of fifteen years of imprisonment. ### GHANA

**Prison officer defends non-custodial sentencing to end overcrowding:** Modern Ghana reported that a chief public relations officer of the Ghanaian Prisons Services said that overcrowding in prisons can be reduced if legislation is passed to give effect to non-custodial sentencing. According to the report, Courage Atsem said that if non-custodial sentences were introduced in the country's system, accused persons whose crimes did not warrant imprisonment would be rendered to serve other sentences including community service. **Lengthy detentions and poor conditions in prisons:** VOA reported that awaiting trial prisoners in Liberia detention centres sometimes wait years before their cases are sent to court. A 35-year-old prisoner said that he had been in prison for more than a year, where he is being held under very harsh conditions. The report said the prisoner added that the prison facility is overcrowded and the government is taking long to prosecute his case and the cases of others. ## KENYA

**Seven Somali nationals imprisoned:** News 24 reported that a Kenyan court convicted and sentenced seven Somali nationals accused of committing piracy. The report said each of the offenders got a five year sentence. According to the report, the men were found guilty of attacking a German ship while it was in the Gulf of Aden in March 2009. **TB patients held in prisons:** It was reported that the Kenyan authorities are holding tuberculosis patients who do not complete their treatment in prison. According to the report, this follows the existence of a law which allows officers to take the necessary actions, including detaining patients to prevent the spread of diseases. However, the report said that the infected prisoners are being kept together with other prisoners and experience the same treatment as common criminals. **ICC's Moreno Campo announces prosecution plan:** It was reported that the International Criminal Court (ICC) chief prosecutor Luis Moreno-Ocampo announced plans to charge up to six individuals who bear the greatest responsibility for the violence that followed the presidential elections in 2007. The report said that Ocampo's announcement was made days after the Kenyan Justice Minister, Mutula Kilonzo, had been criticised for having said that with the passage of a new Constitution, Kenya is ready to prosecute perpetrators. **Prison congestion and lengthy pretrial detention:** A report said that more than 17 164 prisoners are being held on remand for between five and seventeen years in Nigerian prisons without their cases being concluded. According to the report, they were part of a total of 34 328 prisoners who are awaiting trial in prisons in Nigeria. ## RWANDA

**President's opponent gets a life sentence:** It was reported that a court in Rwandan has sentenced an opposition party leader to life imprisonment after it found that the man was planning to overthrow President Paul Kagame. The report said that Deogratias Mushayidi was also given two other lesser sentences for a fraudulent passport and for spreading rumours to incite civil disobedience. **French court negates extradition of genocide suspect:** It was reported that a French court rejected Rwandan authorities request to extradite a Rwandan doctor suspected of committing genocide in 1994. ## SENEGAL

**Teacher sentenced for forcing children to beg:** It was reported that a court in Senegal sentenced seven teachers to one year imprisonment each for forcing children to beg. According to the report, a law which criminalised the forcing of other persons to beg was passed in 2005, but it had not been implemented. The report said that this was the first time that a court had handed down a sentence for such an offence. However, the report also said that the sentences will only be enforced if the teachers commit a similar offence within the next six months. **Amnesty International denounces abuse of prisoners:** Associated Press reported that Amnesty International said that prisoners in Senegal are routinely abused and the perpetrators rarely face punishment. **Uganda and Rwandese prison chiefs meet in Kampala:** A report said that the heads of the national prison services from Rwanda and Uganda met in Kampala to enhance cooperation between the two countries. **MDC activist trial postponed:** AllAfrica.com reported that the trial of an activist of the Movement for Democratic Change (MDC) had been postponed to a later date in September 2010. According to the report, Mapfumo Garutsa had been abducted in 2008 and detained for 22 days on allegations that he had committed acts of terrorism. The report also said that while in detention Mapfumo had been repeatedly assaulted and denied food.
